5. Both parties agree that prior written approval is required before using the other Party's name, logo, or other Intellectual Property Rights in any advertising or associated publicity.
6. Should the collaborative research activities under this MoU result in any potential for intellectual property, each Party shall seek an equitable and fair agreement as to ownership and other property interests that may arise.
7. This MoU may only be amended or modified by a written agreement signed by the representatives of each Party.
8. This MoU is valid for a period of five years from the date of signing by the authorized signatories of each Party. Each Party shall review the status of the MoU at least three months before the end of the five-year period to determine whether it wishes the MoU to continue and, if so, any modifications that might be necessary. The period of validity of this MoU may only be extended by the mutual written consent of both Parties.
9. This MoU may, at any time during its period of validity, be terminated by one of the Parties upon prior notice to the other in writing not later than six months before the termination date.
10. Each Party therefore agrees that the contents of this MoU and the negotiations in relation to any future proposal remain strictly confidential and each Party hereby undertakes not to disclose the same to any third Party.

PREAMBLE

Whereas, State Forest Research Institute (SFRI), Jabalpur established in 1963, is a research institute focusing its research activities in the fields of forestry research and biodiversity conservation in Madhya Pradesh. It has strength in not only identifying and articulating intellectual challenges straddling a number of disciplines of knowledge but also in mounting research, training and demonstration projects leading to development of specific problem based advanced technologies that help carry benefits to society at large.

Whereas, On July 15, 1954 Govt. M.H. College of Home Science and Science For Women came into existence with only Home Science classes. Mr. Parmanand Blai Patel's, firm Mohanlal Hargovinddas donated Rs. One Lakh for the establishment of the college. On April 27, 1956 the foundation stone was laid down on 11 acres of land, situated in the heart of Jabalpur city, by the chief minister of MP. The college is affiliated to Rani Durgavati Vishwavidyalaya, Jabalpur which awards degrees to the students. University Grants Commission, New Delhi implemented the Autonomous Scheme in 1979. The M.H. College is one of the pioneering institutions of Madhya Pradesh that adopted the autonomous system in the Higher Education in 1988-89. On the recommendation of UGC peer team the Autonomous status of the college has been extended up to the year 2012 - 2013. NAAC accredited the college with A grade in 2012.
